PRIVACY POLICY FOR MOBILE APPLICATION "E100MOBILEAPP"

The authorized person for the processing of your personal data (the administrator of personal data) that can be provided by you while using the Mobile application "e100mobileapp" (hereinafter called the «Application»), is LLC "Eurasian Processing Company", registration number 192009206, 224030, Republic of Belarus, Brest, Sovetskaya str., 83, info@epc-it.by (hereinafter called the «Company», «We»,).

We are committed to respecting your privacy and ensuring the transparency of our data processing methods.

The Company has the right to collect, process, store, use and disclose personal information collected by the Application under the terms of this Policy. The Company has the right to determine the purposes and amount of processing of personal data collected in the Application, on the terms of this Policy.

Our processing of data for EU users means the transfer of data to third countries. The Administrator ensures that the transfer of data to third countries complies with established standards, respects internal confidentiality and data transfer rules and applies data transfer security measures.

The fact that you use the Application confirms your unconditional consent to the content of this Policy. This Privacy Policy may be amended. If changes are made, the current version will be posted in the Application or otherwise made available to you for review. If you continue to use the Application after the effective date of the updated version of the Privacy Policy, you will be deemed to have accepted the Privacy Policy as amended.

For the purposes of this Policy, our website is www.e100.eu.

1. COLLECTED INFORMATION

A. INFORMATION THAT WE MAY RECEIVE

As a service provider, We are entitled to interact directly with you and you, in turn, are entitled to provide us with your personal data as part of this interaction.

Since providing data to us, the data subject ceases to be anonymous.

The types of personal data that We may receive and process on various legal grounds:

- Information about the applicant (for example, first and last name, date of birth)
- Contact information (for example, email address, phone number)
- Business contact information (for example, position, organization name, fuel card number)
- User name and password
- Unique identifier of the mobile device
- Certain IP addresses that allow you to qualify them as personal information
- Data on the geographical location
- Other information

All information you provide to us using the Application is automatically uploaded to our servers and stored there as a duplicate of the information stored on your device. If you delete the data from your account, you will no longer see it in the Application, but some backup data may remain in our archives on the servers.

B. . INFORMATION THAT IS AUTOMATICALLY COLLECTED

When you access or use the Application, we may automatically collect the following information:

- Device and Mobile number information: We collect information about the mobile device and mobile number that you use to access the Application, including the hardware model, operating system and version, unique device identifiers and mobile network information;
- Information collected by cookies and other tracking technologies: We use various technologies to collect information about your use of the Application, tracking interaction with specific functions, etc. In order to collect this information, we may send cookies to your mobile device using this Application. Cookies are small data files that are stored on your hard drive or device memory;
- Geolocation. We collect your unique user ID and your location using GPS, Wi-Fi or wireless network triangulation to determine your location for the purposes of providing our Services. We will transmit your current location to the Client's Account hosted on our website. If you disable geo-data transfer, we will not be able to transmit your location information to the Client's Account; however, we will continue to collect information about your location to provide Services.

2. HOW WE USE THE INFORMATION

We use the information received from or provided by you for the following purposes:

- to provide you with services. For example, we use your location and route to calculate available liters of fuel and fuel prices, or to display the location of the fuel card user in the Personal Account for security purposes;
 - to manage the Application, as well as to improve and customize the Application;
 - to provide you with support and handle queries and complaints;
- to send you updates, notifications, announcements and additional information related to the Application;
 - to display or send you marketing and advertising materials when you use the Application,
- to improve the experience of other users. For example, we may use information about your location, as well as your data, to operate, maintain and provide you and other users with the functions and features of the Application;
- to share your data with other users of the Services and to facilitate communication between you and other users;
 - to contact you when we deem it necessary;
- to prevent fraud, misappropriation, violations, identity theft and other illegal actions, as well as the misuse of the Application;
 - to eliminate breakdowns and malfunctions;
- to be able to take any action in any dispute or legal proceeding of any kind between you and the owner of the Application, or between you and other users or third parties in relation to or in connection with the Application;
 - to analyse, operate, maintain and improve the Application and the website;
- to customise the content that you see when using the Application and the Personal Account;
- to provide and deliver the goods and services you request, process transactions and send you relevant information, including confirmations and reminders;
 - to identify the user of the Personal Account;
- to send you technical notifications, updates, security alerts, as well as support and administrative messages;
 - to respond to your comments, questions and requests and provide customer service;
 - to monitor and analyse usage trends and activities relating to our Application;
 - for analytics in order to provide you with better services;
 - for any other purposes disclosed to you during the collection of information.

3. SHARING OF INFORMATION

We do not sell or otherwise disclose the personal data of our users that we collect, except as described herein or disclosed to the user at the time of data collection. We exchange data for the purpose of providing services or performing other actions as part of a business relationship. In accordance with the principles of data transfer to third countries, we may transfer the personal data we collect to the group's companies, commercial branches, subsidiaries, sellers, suppliers and other organisations involved in the process of contracting with E100 Group clients. We may also share this data with our service providers who perform services on our behalf. We do not authorize such service providers to use or disclose this data other than as necessary to perform certain services on our behalf or to comply with legal requirements. We require such service providers, within the framework of their contract, to adequately protect the confidential and personal information that they process on our behalf.

We may share data with business partners with whom we do business. These business partners may contact the user regarding products or services in which the user may be interested. Such third parties may use personal data in accordance with their own privacy policies.

We reserve the right to transfer personal data in the event of the sale or transfer of all or part of our business or assets.

We have the right to publish your reviews and comments online on our website or in the Application.

With the exception of the cases described above, we will not disclose the information received to third parties, except in cases where this is required by law or by a court decision, or by our own decision, if this is necessary for

Except as described above, we will not disclose the information we obtain to third parties unless required to do so by law or court decision, or by our own decision if necessary to (a) comply with the law, to comply with a court decision, or in order to prevent the commission of unlawful acts; (b) to enforce our terms of use, to take measures to prevent violations and incur liability, to verify and defend against any claims or accusations, or to protect the security and integrity of our Application or webs ite; (c) to exercise or protect the rights of the copyright holder of the Application or the security of the Application, Users or others.

4. PERSONAL DATA STORAGE

The period during which we process the data does not exceed the period necessary for the purposes for which this data is processed, so some of the data we process can be deleted immediately, and some of the data can be stored for a longer period of time. In order to provide services, we have the right to store your personal data for the following period of time:

- personal data of the user - for the entire time while the User of Application performs a labor function for the E100 Client;

SAVED INFORMATION

Please note that we have the right to retain certain information after deleting your account. We reserve the right to use your data in any collection of merged data after you have deleted your account, however, we ensure that the use of such information will not allow you to be identified.

5. YOUR RIGHTS REGARDING THE PROTECTION OF PERSONAL DATA

In connection with the protection of your personal data, you have the right to:

- 1) be informed about the amount of processing of your personal data;
- 2) access the content of your personal data;
- 3) request correction of incorrect, inaccurate or incomplete data;
- 4) require the deletion of data or restriction of their processing in cases provided by law;
- 5) obtain a copy of your data, including for the purpose of sending it to another administrator;
- 6) object at any time to the processing of your personal data for reasons related to your specific situation;

7) file a complaint with the supervisory authority regarding the processing of personal data, if you believe that the processing of your personal data was carried out in violation of the law.

6. YOUR CHOICE ABOUT INFORMATION

You have the right to refuse to provide any information, but in this case we will not be able to provide you with all our services.

Changing your account information and settings:

You cannot change your account details or password by logging into your account in the Application. If you have any intentions to review or change your account details, you can contact us: info@epc-it.by.

Third-party tracking:

You have the right to refuse to share your location data with the Client's account on our website by changing the settings on your mobile device to prohibit the Application from collecting data about your location, or you can disable the location services in your account in the Application. Please note that in this case, the Application may not provide you with all possible services if you disable access to location data via your device settings or application.

7. SECURITY

The Company takes care of the security of your information and uses reasonable physical, administrative and technological security measures to maintain the integrity and security of all information that we collect and share with our service providers and clients.

In the event that any information under our control is compromised as a result of a breach of security, we will take reasonable steps to investigate the situation and, if necessary, notify those whose information may have been compromised and take other action.

8. CHILDREN'S PRIVACY

The Application is not intended for children and we do not collect information about children intentionally.

9. THIRD-PARTY LINKS

We are not responsible for the methods used by the websites or services connected to the Application, as well as for the information or content contained therein. When you use a link to go from the Application to another website, remember that our Privacy Policy does not apply to third-party websites or services. Your browsing and interaction with any third-party website or service, including those linked to on our website, is governed by the third party's own rules and policies. Please read these rules and policies before proceeding use.

10. JURISDICTION

The company is located in the Republic of Belarus and the information we collect is governed by the laws of the Republic of Belarus. Please note that Belarusian law and laws of other countries may not provide the protection that the laws of your jurisdiction provide.
